



DESCRIBE CIRCUMSTANCES OF THE ACCIDENT (10 Dec 2018, 740am)

Time is around 7:40 am. Taxi SHC 7452 is in front of my car SJK 175J, entering into AYE (Town direction) from Clement Ave 6. Both cars are in stationary and Taxi SHC 7452 starts to move out. ~~I turned my head to check for incoming cars from right side~~ I start to inch forward and turn my head to check for incoming car from right side. When I turn back, the taxi did not move out. ~~and jammed~~ hence I jammed my brake and hit his bumper.

There are no incoming cars from right side and there is no reason for taxi not to move out. ~~and suggest~~ Taxi driver looks tired and may have misjudged his turn resulting in him jamming / stopping WBS taxi. Would suggest to obtain his in-car camera to justify why he did not move out.
