REFER TO POLICE REPORT - F/20181201/2115 LODGED AT PUNGGOL NPC. I AM WORKING AS A PARKING ENFORCEMENT OFFICER WITH CERTIS CISCO. ON 01/12/2018 AT ABOUT 2040HRS, I WAS TRAVELLING ALONG PUNGGOL DRIVE TOWARDS SENTUL CRESCENT AT THE FIRST LANE AND THERE WAS A LORRY BEARING REGISTRATION NUMBER WC4361T IN FRONT OF ME. I THEN SPOTTED ANOTHER LORRY PARKING ON DOUBLE YELLOW LINES AT THE SAID LOCATION AND DECIDED TO ADVISE THE DRIVER TO MOVE OFF. SUBSEQUENTLY I PARKED THE COMPANY'S MOTORBIKE BEARING REGISTRATION NUMBER FBN1709K IN FRONT OF THE SAID LORRY AND ALIGHTED FROM THE VEHICLE. WHILE I WAS WALKING TOWARDS THE PARKED LORRY, THE LORRY WHICH WAS EARLIER TRAVELLING INFRONT OF ME, STOPPED HIS VEHICLE AND REVERSED. THE LORRY THEN HIT ONTO MY BIKE. HOWEVER, THE MOTORBIKE DID NOT DROP AND ONLY SUSTAIN SOME SCRATCHES ON THE FRONT MUD GUARD. AS SUCH, I AM LODGING THIS REPORT FOR RECORD PURPOSE AS INSTRUCTED BY THE COMPANY. THAT IS ALL.

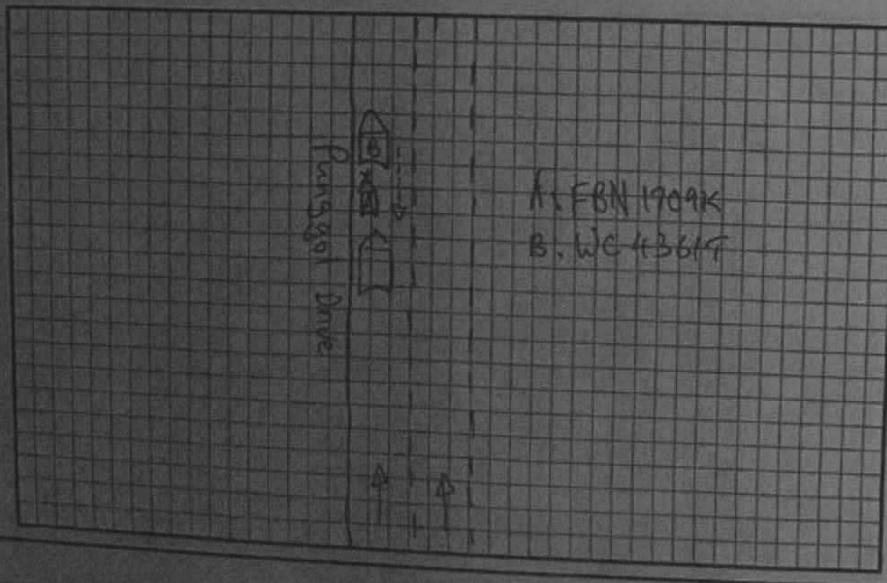

I then spotted another lorry parking on double yellow lines at the said location and decided to advise the driver to move off. Subsequently I parked the company's motorbike bearing registration number FBN1709K in front of the said lorry and alighted from the vehicle. While I was walking towards the parked lorry, the lorry which was earlier travelling infront of me, stopped his vehicle and reversed. The lorry then hit onto my bike.
