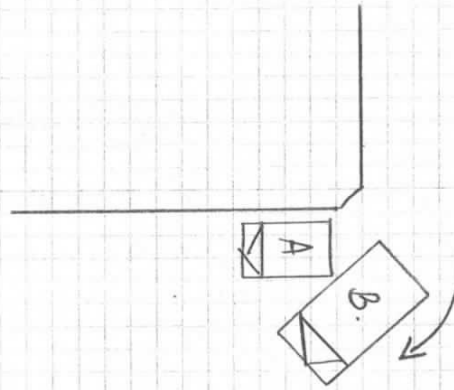

 - (ii) investigating the accident and/or my claims;
