
I understand, acknowledge, agree and consent that:

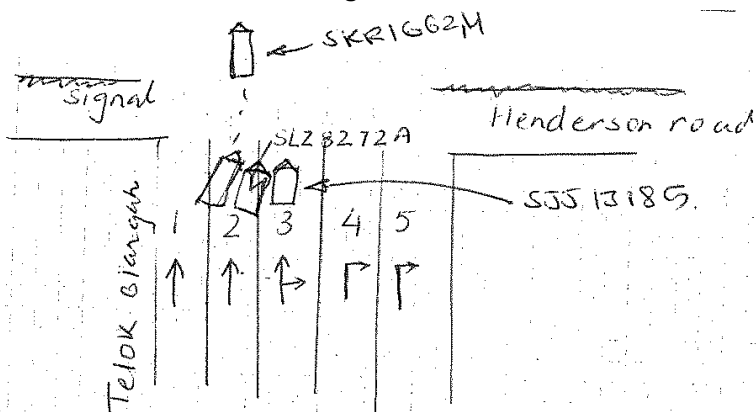

## DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On December 11, 2018, I had picked up my husband from Harbourfront and we were on our way to Lakeside. On Telok Blangah road, before the signal (right turn for Henderson road) I was in lane 3. There was a car in front of me Honda HRV SJS 1318G with its left indicator on but was not moving. The traffic light was green for vehicles going straight. After checking that there is no car behind in lane 2, I gave my left indicator and checked once more for any car and slowly turned into lane 2. I had straightened my car in the lane 2 when we were suddenly bashed on our left side (front) by Subaru Forrester SKR 1662H which was at high speed on a wet road, <sup>and not in lane 2</sup> where there is a bend just before the signal. The driver of car SKR 1662H had to apply brakes to stop his vehicle before the signal. Due to the impact of the collision, our car veered to the right and bumped into SJS 1318G. As our car (driver side) was pinned against SJS 1318G, my husband went out and spoke to the driver of car SKR 1662H and asked him about the procedure to be followed as we had never met with any accident in the last 10 years. He said that he has had similar accidents before and we just need to report to our insurance company. We did that and called a BMW assist.

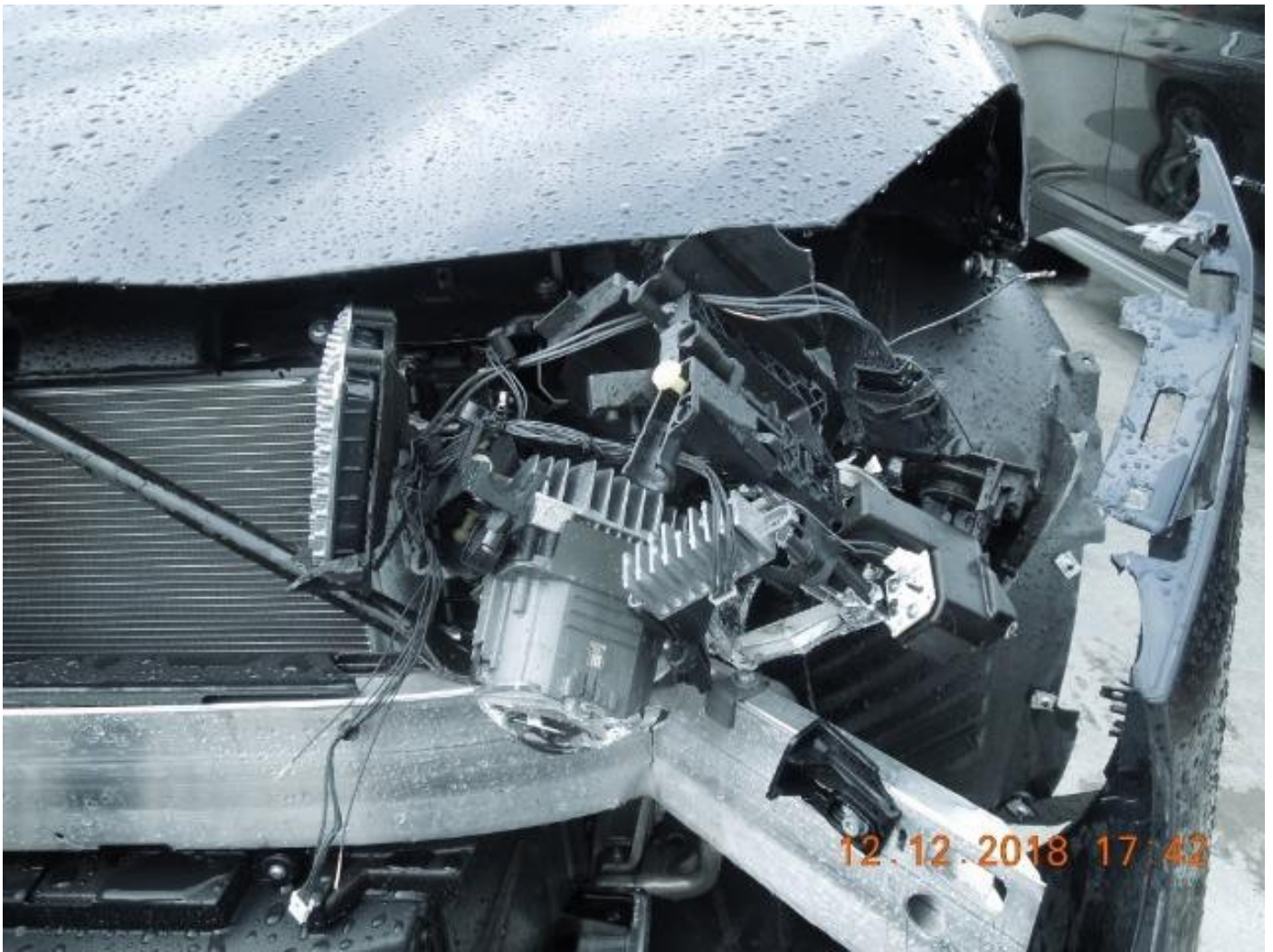
