May I seek your assistance to perform a detailed mechanical inspection of the 5 vehicles below:

a) Case IAFP-IB-20181129 - Mechanical Inspection of Motorcycle, FBG3474K (TP/IP/48921/2018)

On 29 August 2018, sometime before 6.05 p.m., the Deceased was riding a motorcycle, FBG 3474 K, along Pasir Panjang Road towards West Coast Highway while the Involved Party was travelling on the opposite direction towards Telok Blangah Road. The Involved Party made a right turn at the junction of Harbour Drive, resulting in a collision with the Deceased, who was travelling straight. Deceased suffered critical injuries and was conveyed to the hospital in a unconscious state. He passed away later on the same day.
