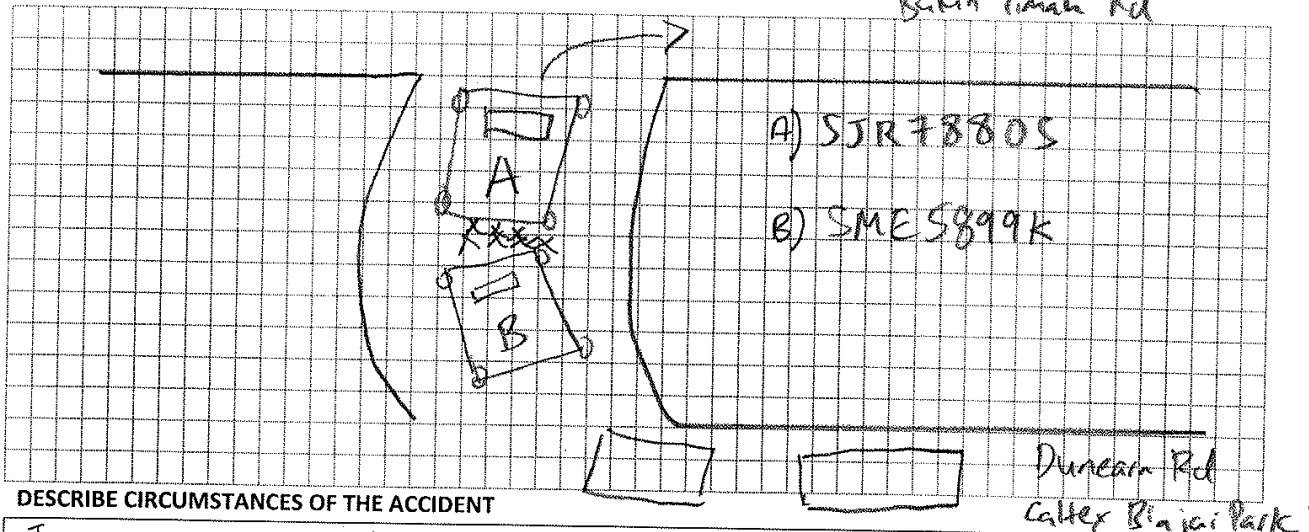





SKETCH PLAN




