OI reported that a Malaysia vehicle lost control and collided onto TPV, causing TPV collided onto OIV.

TP reported that Malaysia vehicle lose control and spin towards his lane, TP could not stop in time and knocked onto the Malaysia vehicle, the Malaysia vehicle continued to spin towards OI'S lane and collided onto OIV, OI tried to avoid and collided onto TPV. There are some conflicting version of collision sequence between TP and OI.

We received the PIR from TP which is against the Malaysia vehicle. As such, we propose to re-direct the claim to the Malaysia vehicle.
