CONTINUATION OF REPORT

Brief Details.

ON 15/12/2018 @ ABOUT 1400 HRS, I AM THE DRIVER OF M/CAR SMC3905A. MY M/CAR WAS THE 1ST OF THE 6 CARS COLLISION. I WAS TRAVELLING ON THE EXTREME RIGHT LANE OF THE 3-LANE ROAD. AT THAT POINT OF TIME, THE ROAD WAS QUITE CONGESTED. I WAS TRAVELLING STRAIGHT WHEN SUDDENLY A CAR THAT WAS TRAVELLING INFRONT OF ME SUDDENLY BRAKED. SO I ALSO BRAKED AND MANAGED TO STOP SAFELY BEHIND THE CAR. THE CARS INFRONT STARTED TO MOVE OFF AGAIN. WHEN I WAS JUST ABOUT TO MOVE OFF, I FELT AN IMPACT FROM BEHIND. I FELT AN IMPACT FROM BEHIND FIVE TIMES. I GOT OUT AND SAW THAT THERE WAS A CHAIN COLLISION.

I THEN PROCEEDED TO TALK TO THE OTHER DRIVERS AND WE ALL EXCHANGED PARTICULARS EXCEPT FOR THE DRIVER OF THE 5TH M/CAR IN THE CHAIN COLLISION. AS WHEN WE MOVED OUR VEHICLES APART TO TAKE PICTURES OF THE VEHICLE LICENSE PLATES, THE 5TH M/CAR JUST MOVED OFF. THEN THE POLICE AND AMBULANCE CAME. TWO PEOPLE WERE CONVEYED TO THE HOSPITAL AND I WAS UNINJURED.


