### **Circumstances of Accident**

I WAS DRIVING ALONG CENTRAL BOULEVARD TURNING ONTO MARINA COASTAL EXPRESSWAY TUNNEL ENTRANCE. I WAS IN THE LEFT LANE OF THE TWO LANES THAT WOULD MERGE INTO ME AT THE TUNNEL ENTRANCE. A VAN, VEHICLE NUMBER, GBG6294T, WAS IN THE RIGHT LANE BEHIND ME. AS THE TWO LANES CONWERGE / MERGE, GBG6294T, SPEED UP AND KNOCKED AGAINST MY RIGHT HAND SIDE MIRROR, WHICH CAUSED VISIBLE DENTS AND SCRATCH MARKS. THE DRIVER OF GBG6294T WAS VERY UNREASONABLE AND STARTED TO BLAME ME FOR CAUSING THE ACCIDENT. I FOUND IT VERY DIFFICULT TO HAVE A CONVERSATION WITH HIM. I DECIDED IT WAS BEST TO TAKE IN-CAR CAMERA RECORDING (AND PHOTO OF GBG6294T) AND MAKE A POLICE REPORT.I WENT TO THE RIVER VALLEY POLICE POST (NEAR MY HOUSE AND MET SGT. MARCUS TEO, HE RECOMMENDED THAT IS MAKE AN INSURANCE REPORT.
