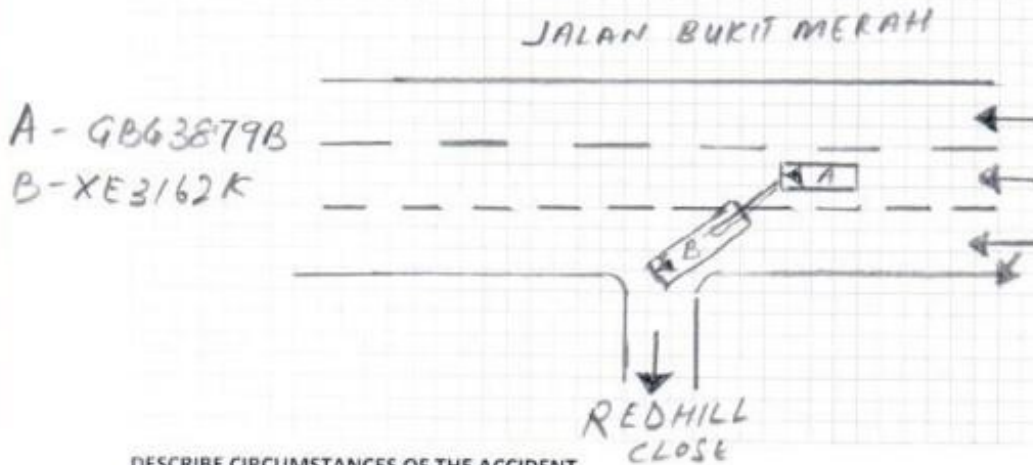

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

ON 12th December 2018 at 1528hrs, I was travelling along the road of Jalan Bukit MERAH. The location that I was travelling slightly before red hill close, ahead of me there was a long vehicle B carrying a load of 2-beams that was making a turn into redhill close, as vehicle B was making a turn the load of 2 beams that it was carrying came into my lane causing me to swerve my vehicle A to the right to avoid full frontal collision. In the event the 2 beams hit the left side of the vehicle A which I was driving.

I would like to highlight that the long vehicle B was making a turn in the last lane and I was travelling on the second when the following occurred.
