

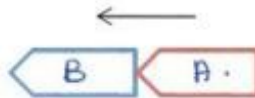
Sketch Plan

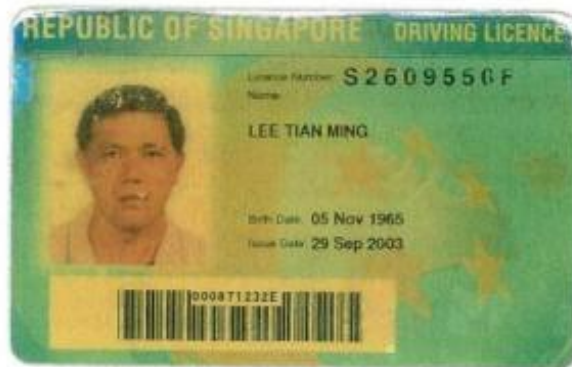
