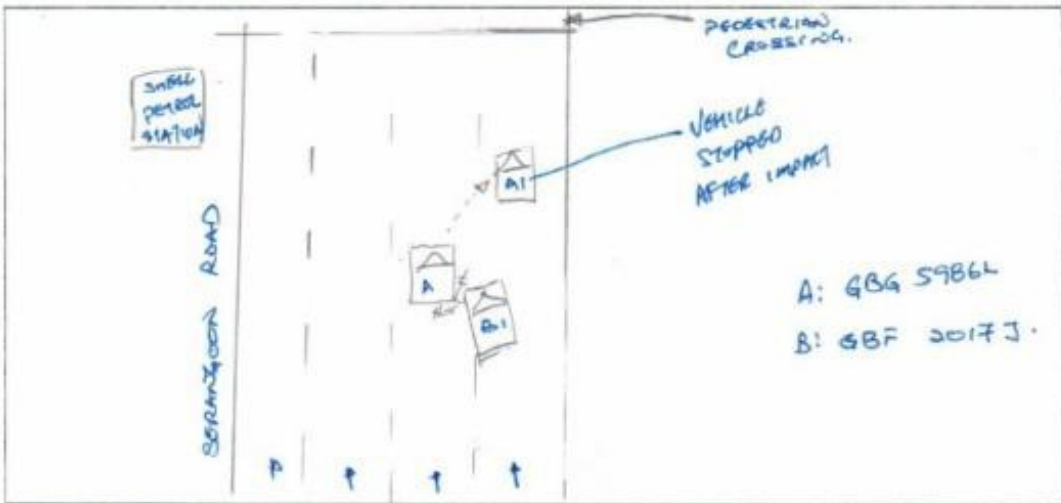

I WAS TRAVELLING ALONG SERRANJOUR ROAD TOWARDS  
 TOWER ROAD DIRECTION ON THE SECOND RIGHT LANE, AS I  
 WAS TRAVELLING STRAIGHT, NEAR TO SHELL PETROL STATION,  
 ONE M/LORRY GBF 2017J SUDDENLY ENCRUGHED INTO MY PATH  
 AND COLLIDED ONTO THE REAR RIGHT PORTION. DUE TO THE  
 HEAVY TRAFFIC, I MOVED MY VEHICLE TO THE RIGHT MOST LANE  
 AFTER THE ACCIDENT. I WOULD LIKE TO STATE THAT I WAS  
 TRAVELLING STRAIGHT WHEN VEHICLE (B) SUDDENLY SWERVED TO  
 MY LANE FROM THE RIGHT MOST LANE, THUS RESULTING IN  
 THE ACCIDENT.
