
SKETCH PLAN



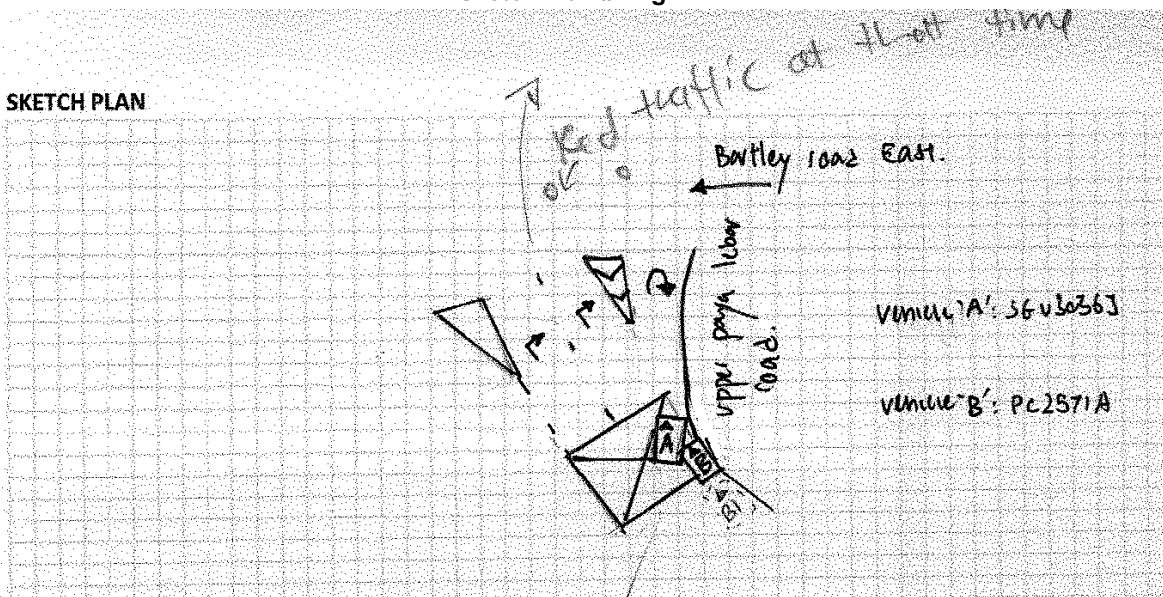

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT


On the stated date and time, i vehicle 'A' was turning out from

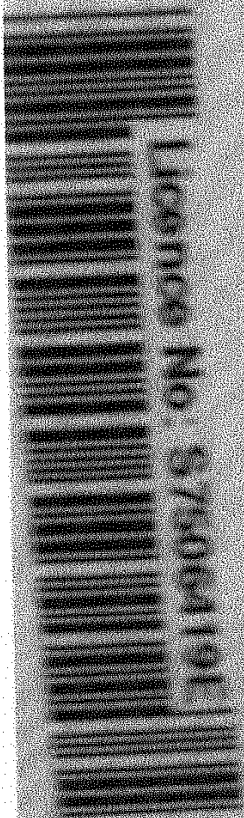
