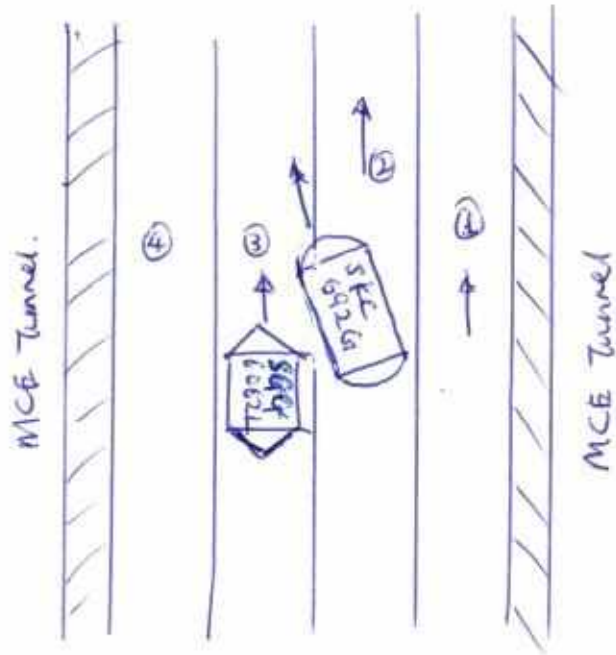

Re: Accident between my car & another saloon car SKC 692G
in the MCE tunnel towards Keppel viaduct on 19th-Dec at 1815hrs.

On 19th-Dec-18 at about 6:10pm, I (Ong Swan Li) the Driver of Toyota Vios with (Reg No: SGC 6062L) was driving along Marina Boulevard Road towards Keppel viaduct, passing through the MCE tunnel.

When I was driving in the MCE tunnel, I was driving like 70km on the 3rd Lane of the 4 lanes Express way.

A couple of minutes in the Tunnel, I saw a silver coloured Toyota with Reg No: SKC 692G driven by (Tan Eng Keong) on my right lane driving very close to my car and

all of a sudden, he tried to over-take to cut into my lane, without signally.

Unfortunately, he could not over-take me but knocked onto the right hand side of my Bumper, and right side wingguard creating a dent and many rubbing scratches on the right corner.

The Driver of SKC692G & I drove to the shoulder of the Express way, as the flow of traffic was quite high. There was only a small dent on the left hand rear corner of his car.

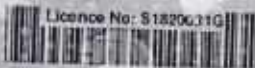
