## DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I, Barry Ong was driving on lane 3 along Sengkang East Rd. Taxi driver Wee Tiong who was directly in front of me came to a sudden stop when traffic was supposed to be flowing. Wee Tiong had faulty brake lights which did not work when he braked. I stopped and started to horn. Wee Tiong proceeded to accelerate slightly and I decided to filter left as it is clear he was having issues with his car. Little did I expect, Wee Tiong braked abruptly again, causing my car to hit the left of his rear bumper while I was filtering left. The right front headlights, bumper and fender of my car were badly damaged.
Both of us exchanged particulars. Wee Tiong informed me that his hydraulic brakes were faulty and he was trying to release his brakes at the point of accident. I called the police who verified and confirmed with Wee Tiong over the phone that his hydraulic brakes were indeed faulty. Phone statement by police -

I called for tow truck the next day (26/12/18) as turning steering wheel will twist the plastic of the fender, causing it to drop and entangle the wheel.


