Accident Sketch Plan

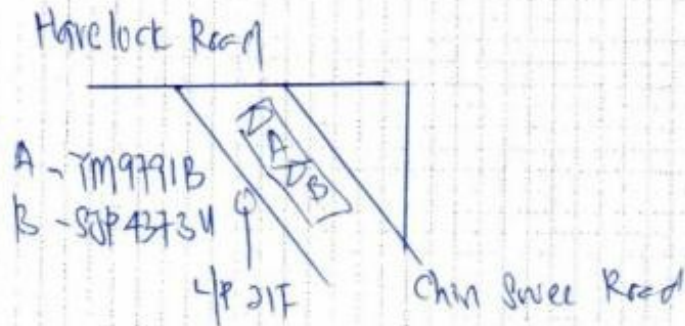
