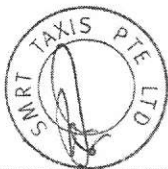

This is pursuant to the inspection conducted on 27/12/2018 (date) at "the workshop".

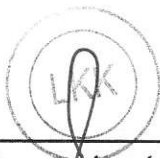

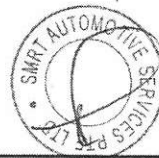
