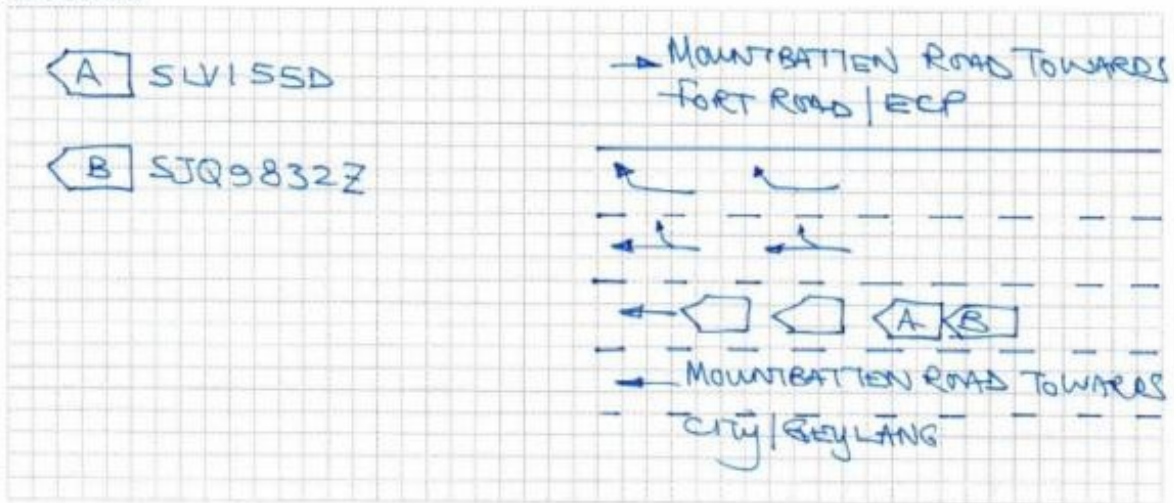

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

ON 28/12/2018 AT ABOUT 0900 HRS, I WAS TRAVELLING ALONG MOUNTBATTEN ROAD TOWARDS CITY. AT THAT MOMENT, MY VEHICLE (REG NO: SLV155D) WAS STATIONARY AS THE TRAFFIC LIGHTS IN FRONT WERE RED AT THE JUNCTION OF MOUNTBATTEN ROAD / OLD AIRPORT ROAD / STAMMUN BOULEVARD. WHILE WAITING FOR THE LIGHTS TO TURN GREEN, I SUDDENLY HEARD A LOUD BANG FROM THE REAR. I IMMEDIATELY REALISED THAT THE VEHICLE BEHIND ME (REG NO: SJQ9832Z) HAD COLLIDED INTO THE REAR PORTION OF MY STATIONARY VEHICLE (SLV155D). NEXT I ALIGHTED FROM MY VEHICLE TO TAKE PHOTOS AND EXCHANGED PARTICULARS. THE DRIVER OF SJQ9832Z, MS SOH KAH LENG (NRIC NO: S83016682) REPEATEDLY APOLOGISED AND ADMITTED THAT THE ACCIDENT WAS DUE TO HER GROSS NEGLIGENCE. FORTUNATELY NO ONE WAS INJURED IN THIS ACCIDENT.
