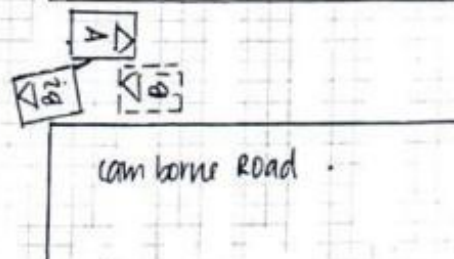
# Accident Sketch Plan
