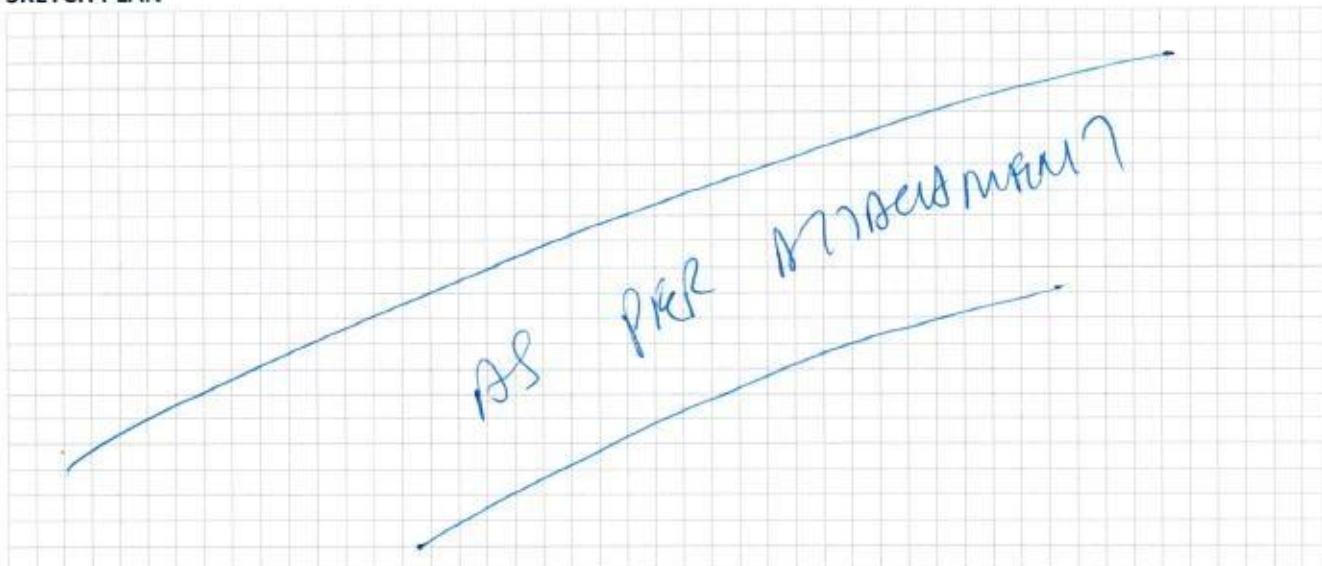

REPORT OF ACCIDENT ALONG UPP CHANGI ROAD INVOLVING MPV (SJN5778P) & LORRY (YN2090G)

On 14 Dec 2018 at around 9.30~9.45 am, I (Kwan Qing Zhong) was driving along Upper Changi road at 30~40 km/h when a lorry (plate number YN2090G) in front slowed down and stopped as if it was going to turn right into Jalan Simpang Bedok. As there was ample clearance on its left, I continued to drive forward but out of a sudden, the driver turned left towards the car park, coming very close to me. I horned and sped forward to avoid him but the lorry still brushed the rear right side of the car. Photo of the damage to the car at the scene is attached. No repair was done as the paint mark was removed using polishing liquid.
