

On 29 Dec 2018, 10:15pm, I was involved in an accident with vehicle ~~GBC5778S~~ GBC5778S. I was travelling along Bedok North Road towards PIE behind vehicle GBC5778S and GBB8757M. As we were approaching the cross junction, which was showing us a green light, an unknown vehicle filter in from ~~our~~ the ^{the} lane on our right, causing ~~GBC5778S~~ GBB8757M to ^{brake} jam brake. Vehicle GBC5778S ^{brake} jam brake in time as well. I did not brake in time and hit GBC5778S. There was no contact between GBC5778S and GBB8757M. There was no visible damage to GBC5778S and the driver felt fine, as such he told me he was uninjured and that he could not be claiming against me. The unknown vehicle got away. My vehicle is 9 years old and my family made ~~the~~ the decision to scrap the vehicle. 
