#### Brief Details.

I parked my car (SLX228S) at Takashimaya Shopping Centre carpark on level 6 near to opposite pillar K14. The car, dark Hyundai, SJS1035A (blurred view from car camcorder) was already parked on my right. At about 3.30pm, when I went back to my car, there was a scrape to my car on the front right bumper.

There was a note from the driver to asked me to contact him to arrange for payment to the damage parts. Driver told me that his name is Rick when I called him at mobile number 97506391 provided in the note.

I contacted the driver, Rick, on same day and from Saturday, 22 December 2018 to Monday, 24 December 2018 through WhatsApp messaging app, he indicated he wanted to settle without involving the insurance,

I visited my car agent workshop (Cycle & Carriage) on 26 December 2018 to get a quote and estimate of the damage to my bumper. However, I was advised that the headlight was out of alignment and may require replacement if the bracket holding the headlight is broken but if not broken, can be knocked back without replacement. This can only be ascertained upon taking out the bumper. The potential damage is estimated to be SGD4,924.62 (including GST). I planned to get this carried out after the New Year as I still need the car during the festive season.

I sent the estimate to Rick on 26 December 2018 explaining the situation. After a few messages, he stops

replying or responding to my calls or messages completely.

#### Note:

- a. There is a CCTV nearby where my car was park at Takashimaya. I approached the security for the footage and was informed that I must make a police report, and the police can view the footage of the incident.
- b. The driver, Rick, indicated he wanted to settle without involving the insurance. The correspondence in the WhatsApp message can be provided as evidence.
- c. The driver refused to give me his vehicle license plate number (from the WhatsApp message).
- d. I have more photos and record of the WhatsApp message as evidence.
- e. Even though the driver leave a note, subsequent non-responsiveness is tantamount to a hit and run situation.
