

CONTINUATION OF REPORT

**Brief Details.**

On the 28/12/2018 at about 1026hrs, I was at the ground floor carpark of IMM building. I had made a left turn and my vehicle was stationary at the side of the carpark as there was another vehicle, SFZ1994S V1, in front of me that was reversing.

V1 was reversing backwards from the drop of point, making a S shaped reverse. However, I realised that V1 was approaching too close to my vehicle. I then press my vehicle horn to warn V1 about this, however it was too late as the right rear bumper of V1 had bumped into the front of my vehicle.

I went down to make a check to realise that my number plate has been damaged due to the impact. I ask V1 if he was aware that his vehicle had knocked into my vehicle, however he denied as there was no damage. I informed him that I have an in car camera, however he insists that he did not knock into my vehicle, and ask for V1's driver particulars, however he refused to provide with me. I then informed him that I will be claiming insurance for this matter, he then challenge me to do so and did not provide his particulars. I wanted to take a picture of the damages of the accident however the driver of V1 then started shifting V1. I was standing behind V1's boot and started knocking on his boot, however he did not stop. I then move away and started knocking on his window, however he carry on reversing.

He then alighted from his vehicle and did not wish to provide his particulars. I then shifted my vehicle to prevent me from obstructing the traffic. I am lodging his report as requested by insurance company. I wish to state that I have an in car camera in my car that recording this incident.
