Brief Details.

On 02/01/2019, at around 1945hrs, I was driving along Elite Park Avenue when I came to a stop behind a Silver Honda vehicle (SLZ3665H) at the junction of Elite Park Avenue and Siglap Road. There is no traffic light at the junction, but there is a stop line at the junction. I would like to inform that the Silver Honda vehicle was seen to have stopped beyond the stop line, and then reversing back. After reversing, the driver of SLZ3665H came out of his exit and claimed that my vehicle had hit him, even though he was the one reversing his vehicle, and there was no contact between the vehicles. However, he had claimed that an existing damage on the right rear side of his vehicle was caused by the collision, even the vehicles did not come into contact. I would like to inform that the driver of SLZ3665H had also hit the bonnet of my vehicle with his palm twice. The driver had also called for Police, but I told him that I am rushing off for a meeting, and told him to take down my license plate number. As I had observed that the driver had started to get aggressive, I reversed my vehicle all the way back to the end of Elite Park Avenue to exit as the driver was blocking our exit in front. I then drove my wife to Marine Parade NPC to lodge a Police report.

I would like to inform that I have in-car camera installed, and I am able to provide the footage if required.

I would like to inform that I am lodging this report as my insurance company requested for me to lodge a report under myself as the other party had lodged a claim against me regarding the incident.
