I was waiting for my wife to come to the car as she had just finished washing her hair at the hair saloon at Blk 186 Toa Payoh Central. After parking, I switched off my engine, reclined my seats and was resting when I heard a loud bang. I sat up and saw a white Volvo, registration number SKZ2441E had hit the right side front of my car as he reversed into the car park lot 55 on right of my parked car. After knocking into my car, the said driver of the Volvo then tried to drive off. I was furious that after knocking into my car, he drove off his car immediately. I rushed out of the car to examine the damage and to note the car plate no of the hit and run driver. I believe that he had originally wanted to drive off his car away but when he realized from his rear view mirror that I had come out from my car, he thereafter decided to park his car into another car park lot a few lots away at lot no. 53. My front right was badly dented. His rear left side near the tyre had scratch marks. I was furious when I saw him driving off after the accident occurred. On normal circumstances, a car is not to be moved until pictures are taken. I walked to his car and approached him. He did not even apologise for knocking into my car nor did he apologise for moving his car away from the accident scene. We exchanged our identity cards and he suggested to file a third party insurance claim. He gave me a written note to indicate his mistake in reversing his car. Only much letter I realised he even mistakenly wrote the date as 31 Dec 2018 My car camera was not working at that point of time. I now attach the pictures and his written note.


