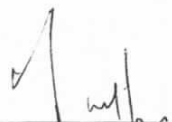

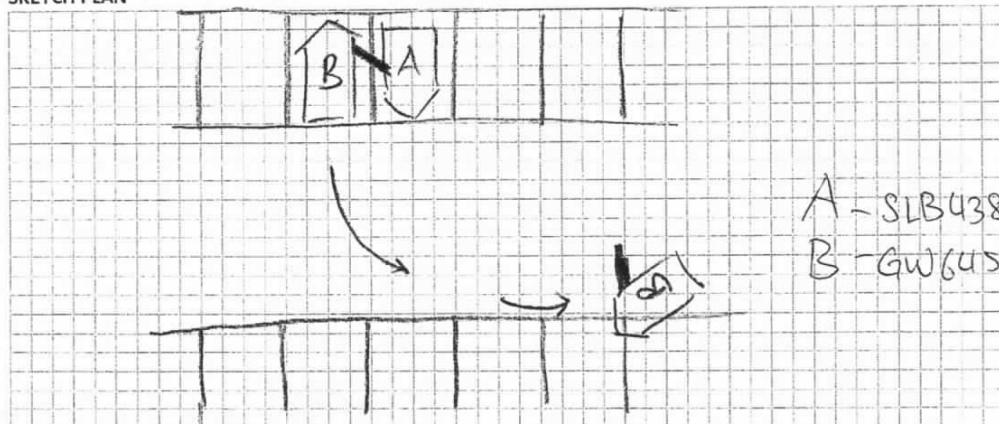

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

The car, Hyundai Tucson SLB4387E, was parked in BLK 109 McNair road carpark, lot 302 overnight. Before leaving for work in the morning with the company van, at 0645 hrs, I checked and saw that the car was in its perfect condition. Upon coming back from work, I parked my van and saw that my car had been crashed into. There were major dents in the driver's door and the door handle was broken, as well as dents and scratches across the front right of the car stretching across the bumper and headlight. The other party was around the car and confessed to crashing his company van into the car. According to the other party he had tried to park the van head 1st in lot 301 when he felt that he may have hit our car. He then stepped out the vehicle to check the issue. When he stepped out of the van, it started to roll backwards further crashing into our car and rolling all the way to lot 295.
