

We, **COMFORTDELGRO ENGINEERING PTE LTD** ("Workshop") hereby agree and confirm that we are authorized by the owner ("Claimant") of motor vehicle **SHC 1921A** ("Vehicle") to accept the sum of **\$3,769.88**, being the amount claimed for **\$2,711.25** (repair costs), **\$751.14** (loss of rental/use), **\$300.00** (loss of income), **\$7.49** (search fees) as compensation for the loss of or damage to the Vehicle, as a result of an accident ("Accident") which occurred on **05/01/2019** (date of accident) at / along **PIE TOWARDS TUAS AFTER TOA PAYOH EXIT** (location) involving vehicle no/s. **SHC 1921A** and **SLL 4450C**.
