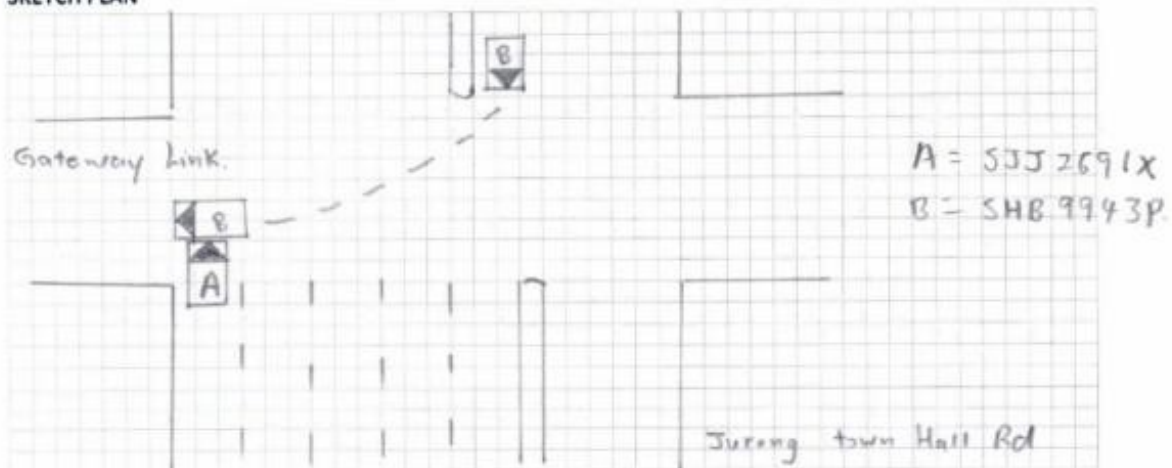

Brief Details.

On the 31/12/2018 at about 2210hrs, I left my workplace and I was driving vehicle SJJ2691X. I was driving toward Jurong Town Hall Road on the extreme left lane of 5 lanes towards West Coast Road. As I was approaching the junction of Gateway Link, the traffic light was green and I proceed straight however a Transcab SHB9943P suddenly came from the opposite direction and made a right turn infront of my vehicle. I was unable to brake in time as such my vehicle collided onto the said taxi. The traffic police and ambulance came to scene to assist and one passenger from the taxi was conveyed by the ambulance.

After the said accident, I started to feel pain as such I proceed to Sengkang General Hospital to seek medical treatment. I suffered pain on my left hand, slight scratches on my right arm, felt pain on both of my legs and pain on my neck area. I was given 5 days of Hospitalization leave by the doctor.
