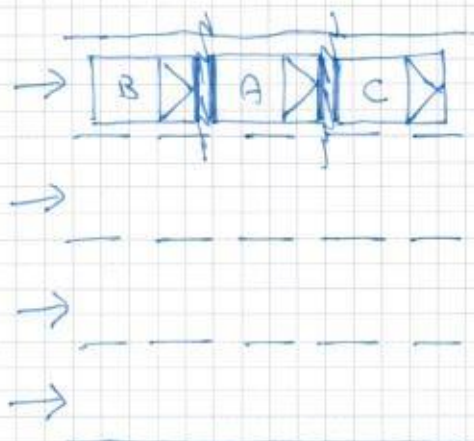

## DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I WAS DRIVING ALONG PIE TOWARD JURONG DIRECTION.

I WAS ON THE EXTREME LEFT LANE.

WHILE DRIVING STRAIGHT AHEAD, DUE TO THE HEAVY TRAFFIC, THE VEHICLE BRAKE TO COMPLETE STOP, AND SO I TOO APPLIED BRAKE TO COMPLETE STOP. SUDDENLY AFTER A FEW SECONDS I FELT A GREAT IMPACT FROM THE REAR OF MY VEHICLE. AND THE IMPACT WAS SO GREAT THAT PUSHED ME FORWARD AND HIT ONTO THE VEHICLE INFRONT.
