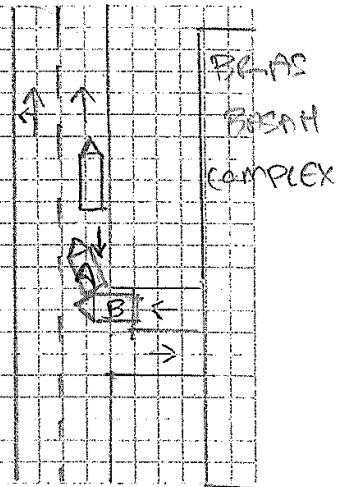


Describe Circumstances of the Accident.
