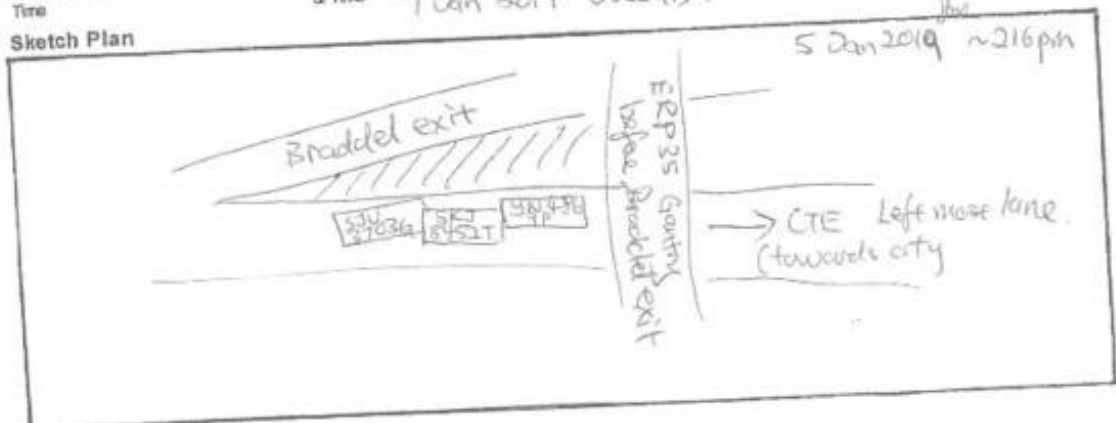

5 Jan 2019 1416hrs Driving on leftmost lane on CTE (towards city).
YN4869P white lorry stalled and stop before ERP gantry before Stables exit in front of me.

I stalled to stop behind YN4869P. Both of us are at complete stop

At least 5-10 seconds later, I see a white car from my rear viewer approaching me and felt a collision from behind. My vehicle was pushed in front until a second collision in front of me with white lorry YN4869P.

On exiting my vehicle, I noted my car was pinned between the white lorry in front and a white Honda Fit SJ037036 behind.



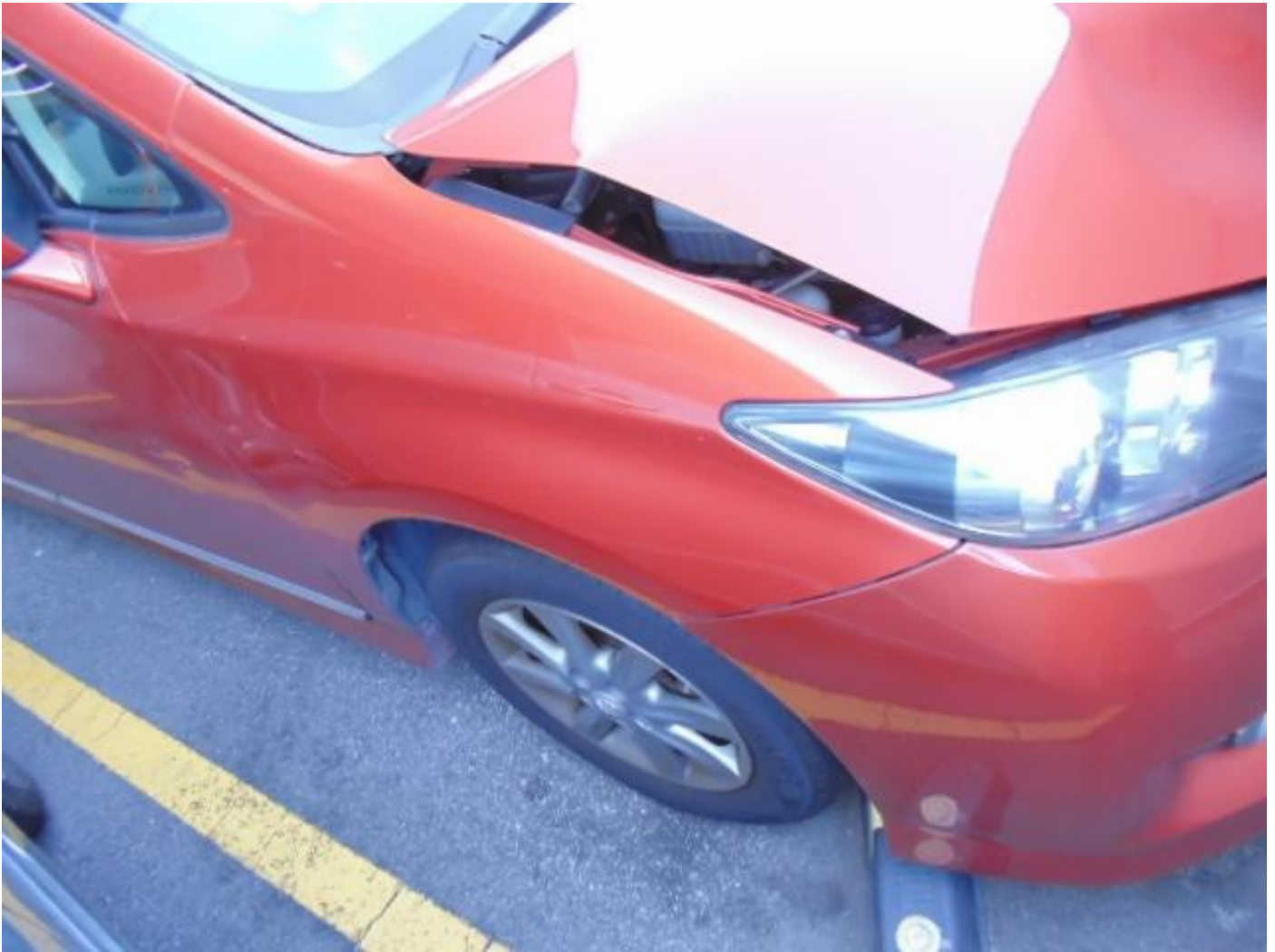
