This vehicle has no value because its COE was significantly high at the time of purchase i.e. \$77,201.00.

The accident in February 2018 is at a time when the COE was about \$36,000.00 value of vehicle.

Traded in the market fluctuates with COE, hence the market value of this vehicle correspondingly drop significantly. Due to the high COE paid by owner, the LTA rebate at time of loss is also high i.e. \$53,531.00.

For such case, we normally would add the body value of the vehicle to the LTA rebate.

Hence the market value of the vehicle is \$58,531.00.


