Brief details.

My car, an Audi A4, license plate no. SLZ 1649 M, was parked (facing out) at Shunfu Mart (MSCP SH2), where I have season parking for this car. On the evening of 22 Dec 2018 (Saturday), I went to my car to drive out for dinner. I discovered the front right-hand side of my car had been badly damaged - including the front side panel, front headlamp and front bumper. Fortunately the car comes with incident-recording front in-car camera which activates when there is movement of the car when it is parked, such as was the case here. 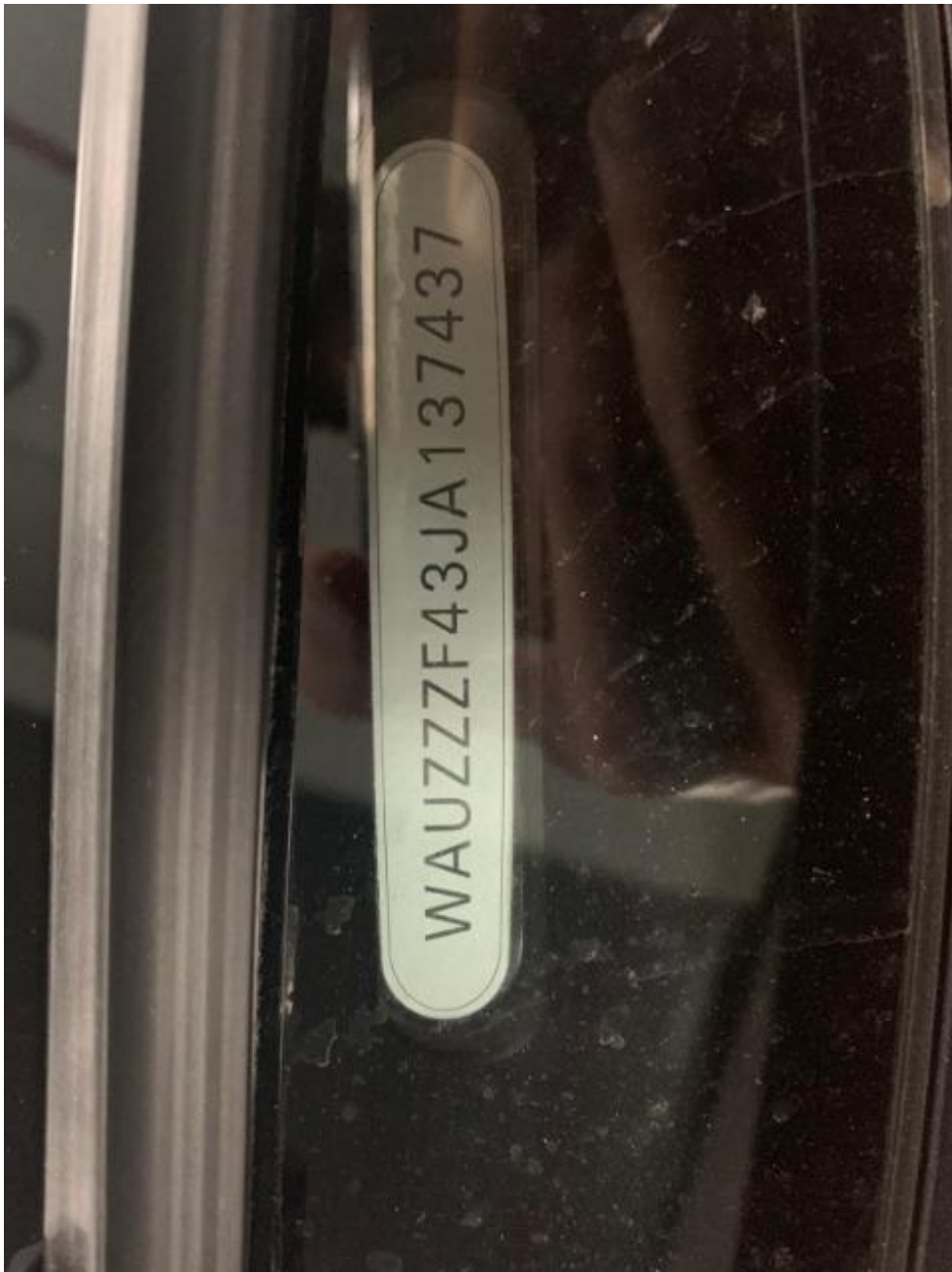
