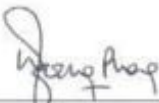

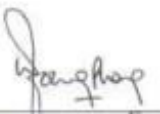

STATEMENT

Account of Accident

I, Ow Wei Yuen (NRIC S9729757F), was driving a Mercedes CLA (license plate number SFP288G) and attempting to turn from the exit of the underground carpark at Bukit Timah Plaza onto Upper Bukit Timah Road at around 1430 hrs on Sunday, 13 January 2019. It was drizzling. I was second in line to turn onto the main road behind a Honda HR-V car (license plate number SLV7628K). As I looked to the left to judge the amount of oncoming traffic, I continued to move forward, thinking there was sufficient space ahead. However, I did not notice that the Honda HR-V in front had stopped and bumped into the back of the Honda HR-V. The driver of the Honda and I exited our cars to inspect the damage. As we were holding up traffic behind, we decided to drive out and stop at the Shell Station (35 Upper Bukit Timah Rd, Singapore 588166) further down the road to further inspect the damage and trade details. The coordinates of the location of the accident are 1.338071, 103.777830. I am making this account as I shall be flying off to the United Kingdom tonight and thus will not be in Singapore until June 2019.
