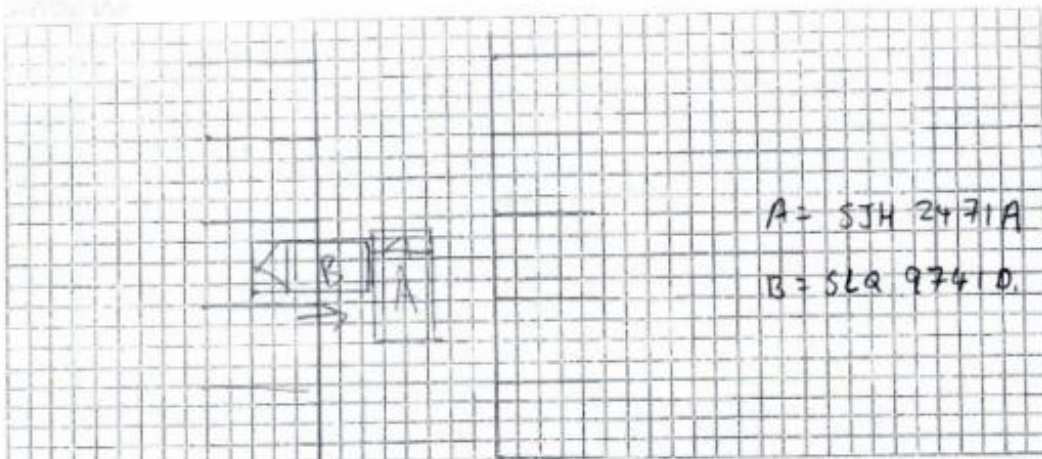

# Accident Sketch Plan




