Dear Mr. Stephen,

We refer to the above matter.

As reported, this is a three vehicle chain collision and your vehicle was the last vehicle. The third party vehicle sustained both front and rear damage as it is the second vehicle in the chain collision.

Our surveyor had physically conducted survey to third party vehicle and is in the view that the damages sustained to the Third Party vehicle is consistent to the nature of accident as reported.

We understand that you would like to know the repair cost on third party vehicle. We have tried to negotiate at best with third party repairer and the adjusted repair cost is \$8,433.10 (before GST) with 7 repair days.
