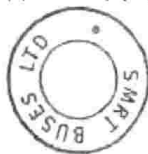

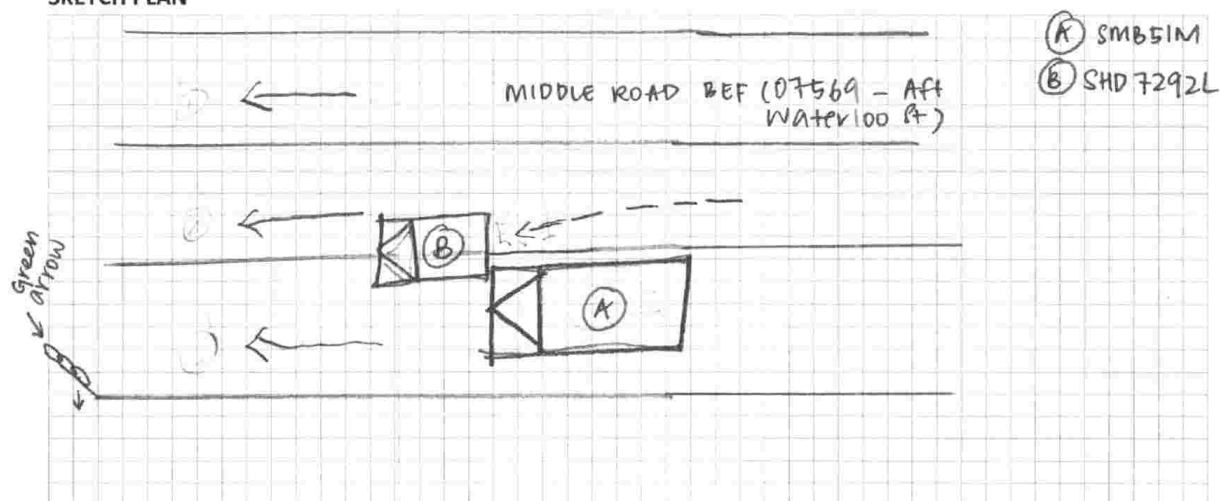

SKETCH PLAN



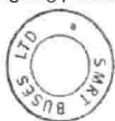
