#### Circumstances of Accident

#straightroad Moving straight & Moving straight SKT869A SJU3134Z WSVC19000093 Accident\_Description It was peak hour traffic on Tues 15 Jan at 6pm on the CTE towards Ang Mo Kio from the tunnel. The traffic was heavy and it had just started to rain. The traffic movement on CTE towards Moulmein exit was intermittent start-stop. On the left merging lanes to the CTE cars slowed down as other lanes 3 and 4 merged and filtered left toward the Moulmein exit. SJU3134Z was indicating right to exit the lane from the left but slowed down suddenly. I misjudged his right indicator and accelerated as I had expected him to move faster. Thereafter my car SKT869A collided with the rear of his car SJU3134Z. I realised I had hit the bumper of his car and got out of the car to apologise and to check if he was OK. Mr Tan Hui Peok is a Grab Private Car Hire Driver and had a passenger in the car. Both were fine at the scene. We took photos of our respective cars I also handed him my business card with my contact details and exchanged pictures of my drivers' licence and his IC. After about 5 minutes we decided to discuss next steps after he completed his ride and decided how to proceed.
