Brief Details.

On 12/01/2019 at about 1210hrs, I was driving along Paya Lebar Road. I had stopped at a filter lane before a zebra crossing as there were pedestrians crossing along the road. I was heading towards Eunos Avenue 5.

Out of a sudden, I felt a huge impact in the rear of my taxi. I discovered that a white Toyota Prius bearing plate number SLH4173Z had collided into my taxi. My passengers were not injured, I have picked them up from Lor Ah Soo and they are headed for Paya Lebar Square. I exchanged particulars with the Prius driver and we parted ways. Due to the collision, I felt pain in the front part of my head and neck area. I went to see a doctor and made a check and was given MC for 5 days from 12/01/2019 to 16/01/2019.

Dents and scratches were seen at the rear of my taxi. Visible scratches were also seen on the white Prius.
