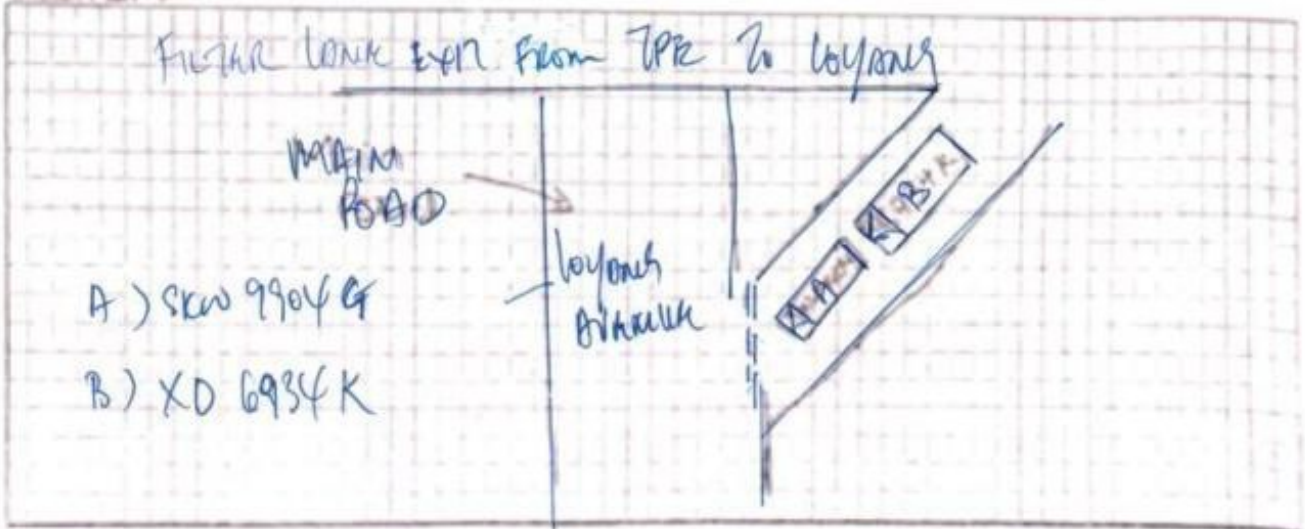

Big truck (XD6934K) came and bang my vehicle from behind. During the accident, I am the first vehicle. I did not knock to any vehicle.
