

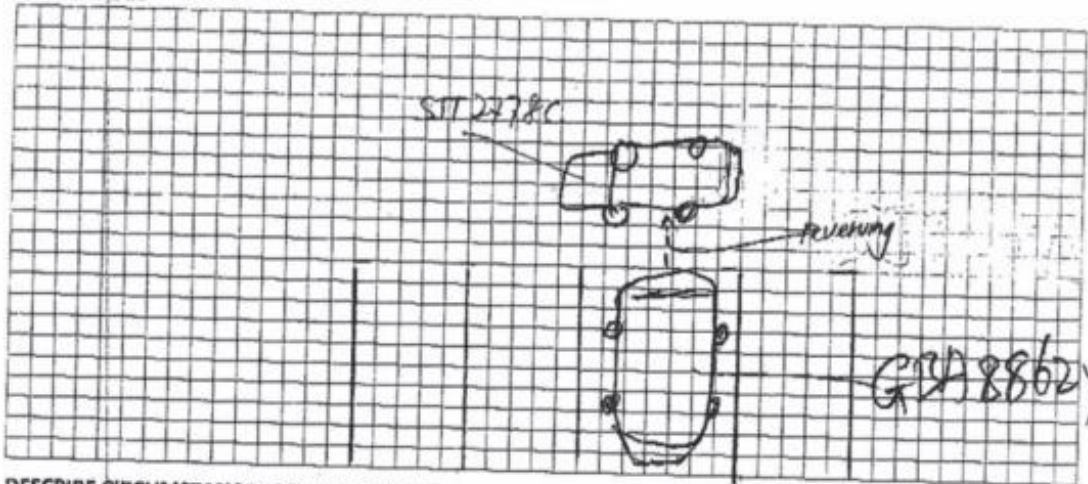


While I was reversing from parking lot, I did not notice there was a vehicle (SJT 2778C) past by and so cause my vehicle hit onto said vehicle while I reverse.

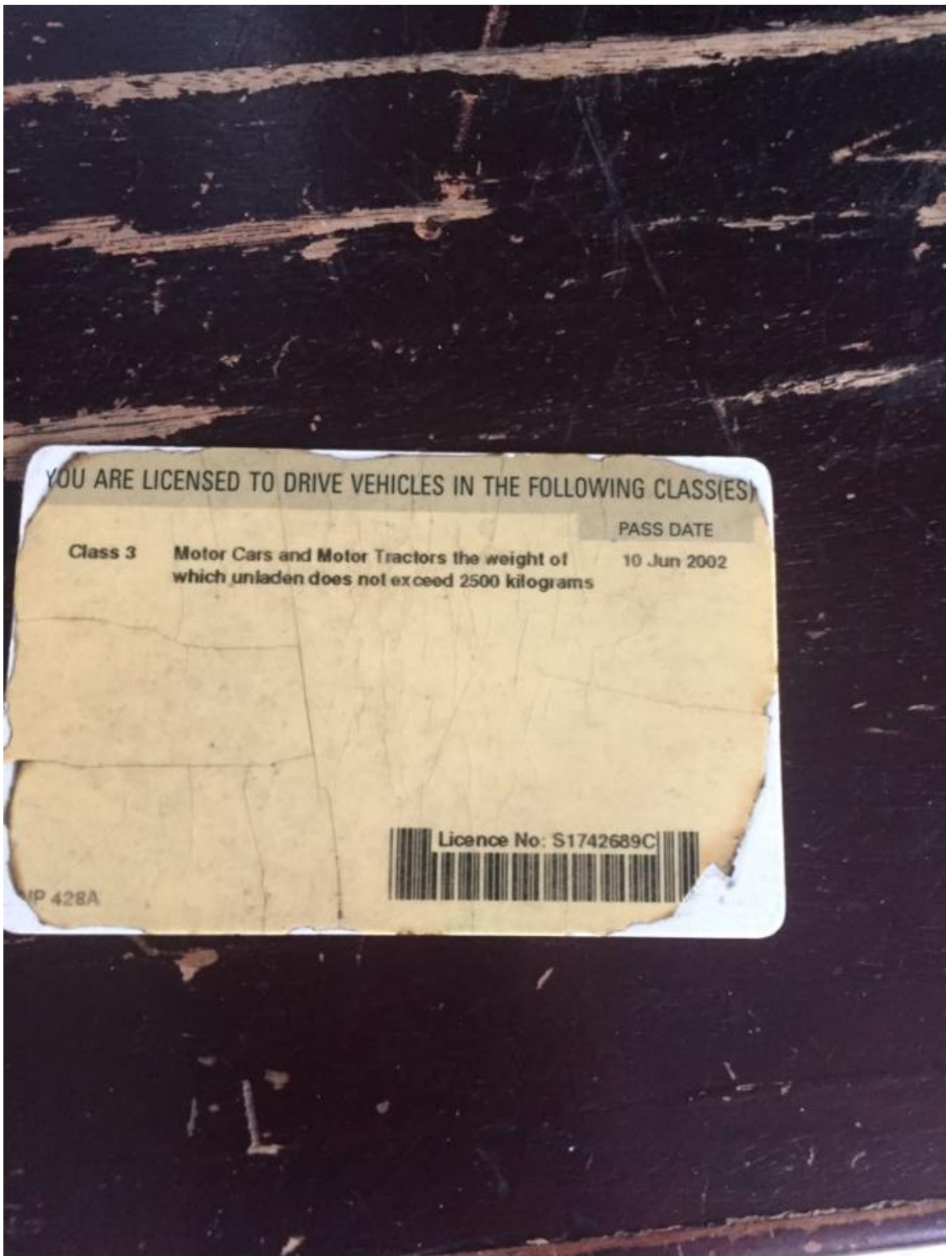

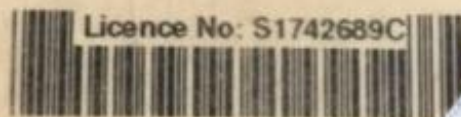
