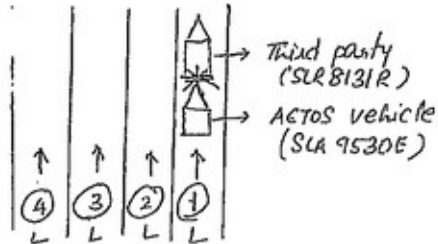

SKETCH PLAN





Brief Details.

On 17/01/2019 at about 1520hrs, I was on Lane 1 of a 4 lane road at Ayer Rajah Expressway. I was alone driving the AETOS Auxiliary Police Saloon Car with vehicle registration number SLA9530E. I was along AYE towards Tuas near to Clementi Road Exit.

At that point of time, I was driving at about 70km/h on Lane 1 and there was a White Subaru Legacy with registration number SLR8131R that overtake me and went in front of me. All the car ahead of me were driving at a considerable speed.

Unknowingly there is another two cars ahead of the Subaru Legacy that had braked and I had to do a hard brake to stop in time. I didn't manage to brake in time and hit onto the car ahead of me which is the Subaru Legacy. That results in the chain collision accident.

I manage to exchange particulars with the Subaru driver only. His Chan Kok Sing, S7613190B, Hp No: 9653 1529

When the car was towed back to the HQ located at West Coast Road, my in-charge discovered that there are damages at the back.

The front part of the car is dented in and head light all crashed. The right rear light casing had cracked, lower bumper has scratches and right bumper is slightly dented out too. There is in-vehicle camera that is facing forward.

The state of the car is quite bad and EMAS Recovery was at scene and towed the car away. I followed the EMAS officers back to my HQ also.

I am here to make a report as advised by my in-charge. I am feeling some pain at the back of my neck.

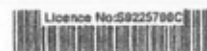
