# Brief Details.

On 19/01/2019 at about 2325hrs, I was driving my rented car, SLS9095A, on the second lane along Serangoon Rd towards Upper Serangoon Rd. I was with two passengers at that point of time. The traffic light was red and I saw a black coloured Toyota Alphard parked about 15m after the traffic light, on the first lane, with its hazard lights on. He gave me his particulars and told me to claim under his company, Diny Tour and Travel Sdn Bhd. None of us, including my passengers are injured and no ambulance was needed. I then called for the police.

There is an in-built camera in my car and the Traffic Police officer took the SD card. He then issued me with an acknowledgement slip and a case card, advising me to lodge an accident report.




