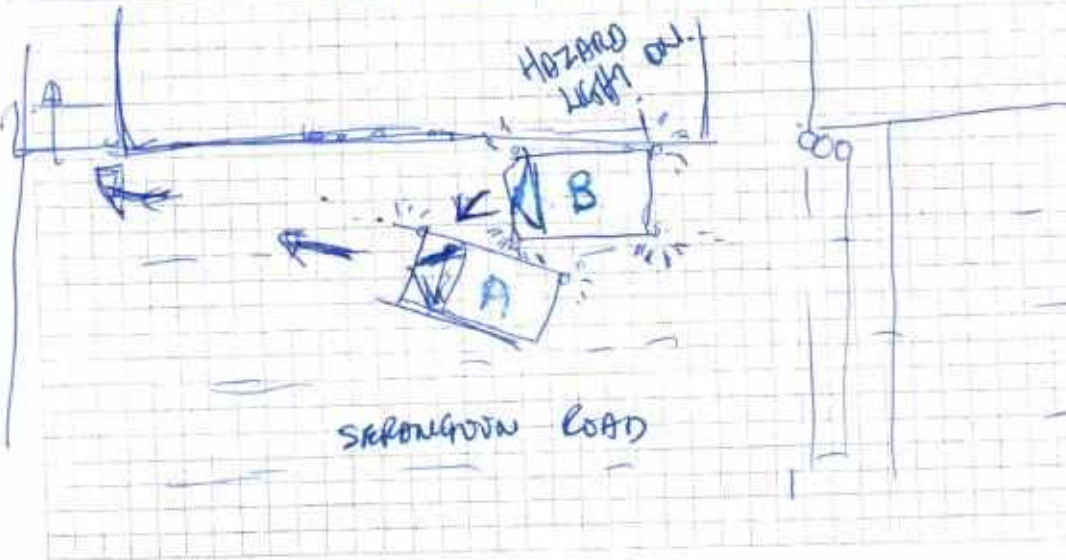

**Brief Details.**

On 19/01/2019 at about 2325hrs, I was driving my rented car, SLS9095A, on the second lane along Serangoon Rd towards Upper Serangoon Rd. I was with two passengers at that point of time. The traffic light was red and I saw a black coloured Toyota Alphard parked about 15m after the traffic light, on the first lane, with its hazard lights on. As I overtook his vehicle, I signaled and intended to change lane to the first lane. I changed lane and suddenly I felt an impact from the right side of my vehicle. The black Alphard had collided onto the center portion of the right side of my car. I moved to the side and got out of my vehicle to make a check. I saw that the black Toyota, JNG3366, was with one male Malaysian driver, there was no passenger in the car. I noticed that there were dents and scratches on both the front and rear doors on the right side of the my car. I can still open both doors. His vehicle suffered some scratches on the left side of the front bumper. The driver told me that he did not see my car approaching and admitted that it was his fault. He gave me his particulars and told me to claim under his company, Diny Tour and Travel Sdn Bhd. None of us, including my passengers are injured and no ambulance was needed. I then called for the police.

There is an in-built camera in my car and the Traffic Police officer took the SD card. He then issued me with an acknowledgement slip and a case card, advising me to lodge an accident report.

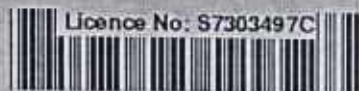
