Accident Report by SJT 2933X

Accident Report involving SJT 2933X, SDN 881C & YM 7106T on Saturday 19/01/19 at around 1.15pm along Woodlands Ave 2.

On Saturday afternoon, around 1.15pm 19/01/19 I was travelling along Woodland Ave 2 toward Ave 9. I stopped at a traffic light just outside the Singapore Sports School. In front of me there were a few cars. Behind me was also another car.

As the traffic light turns green and I was about to move off, I heard a loud squeaking sound from behind me and after a few second I felt my car jerk forward.

I applied brake to my car & stopped my vehicle. Luckily the few cars in front of me had already move off. Upon inspection, I discovered that my car was hit from behind by SDN 881C. Right behind SDN 881C was a Lorry YM 7106T.

The Lorry YM 7106T had hit SDN 881C from the back resulting in SDN 881C hitting my vehicle SJT 2933X from behind.

Upon confirming that there were no injury, I exchanged particulars & took some photograph & I left the accident scene around 1.45pm.

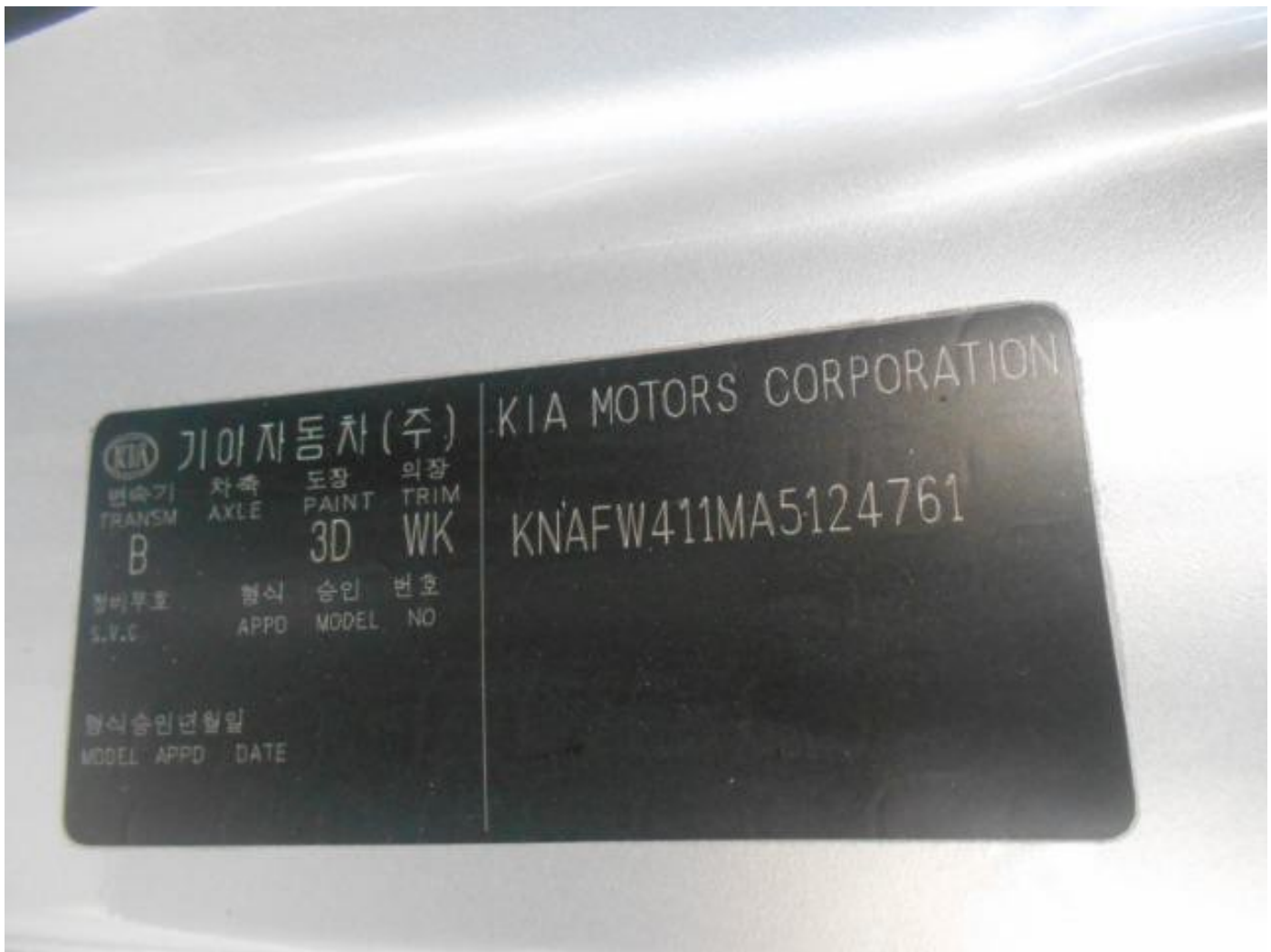

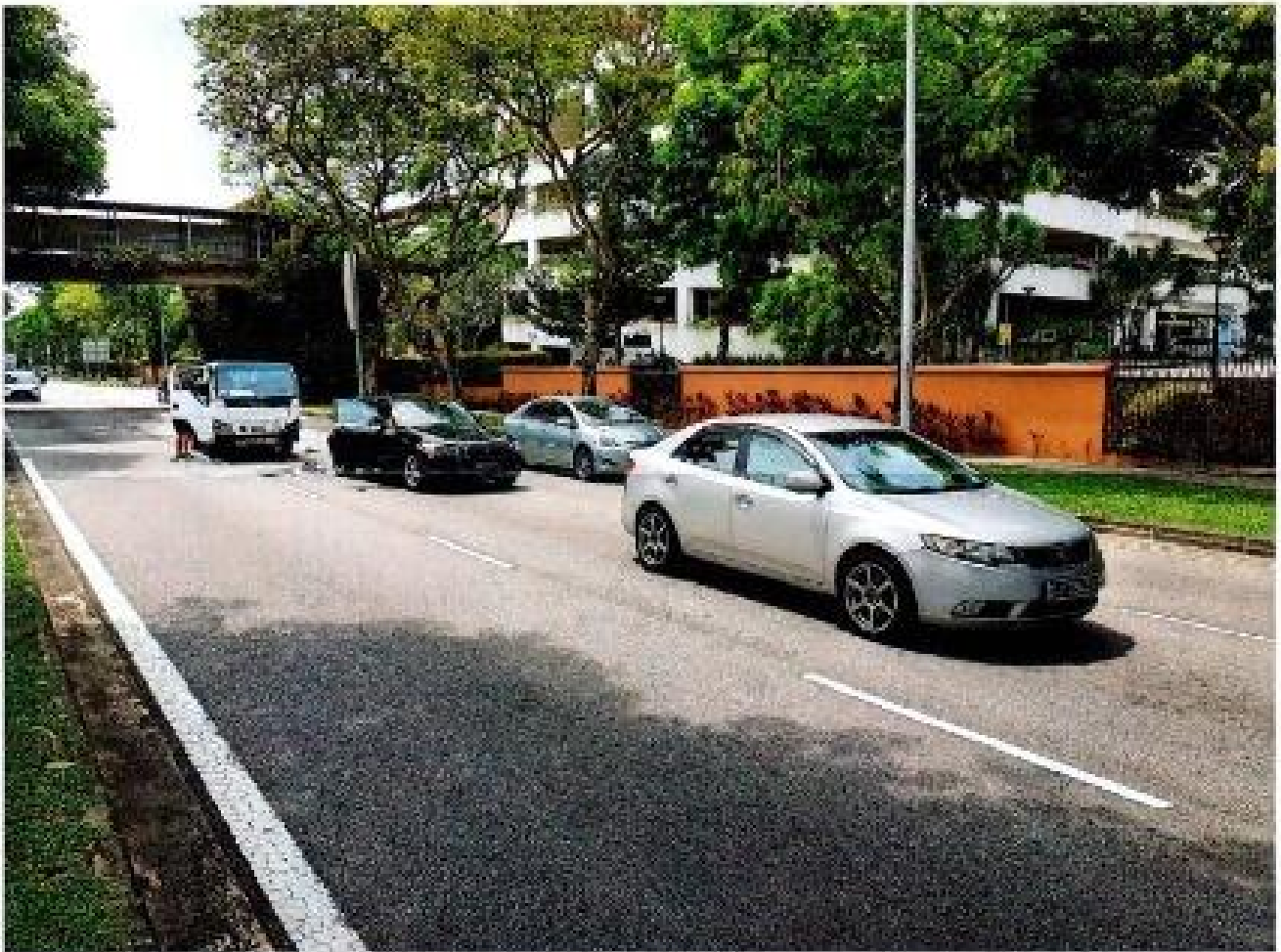
