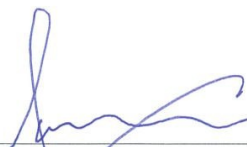

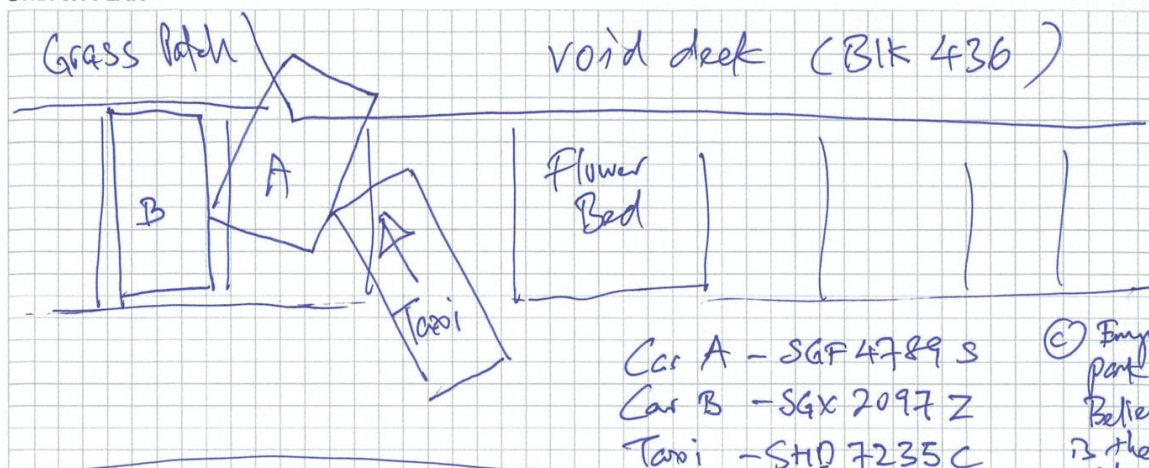

On 20/1/19 (Sunday), I received a call from my dad that someone had rammed into my parked car at Blk 436, Jersey West Ave 1 carpark. On arrival, I saw the taxi driver (Mr Stephan Anathas Pnk IC: 830357852) of Comfort Delgro taxi bearing car plate STD 7235 C) inspecting the crash site. Mr Stephan explained that he was just starting his shift when his taxi accelerated forward and crashed into my car.

The impact caused my car to move diagonally backward and to the right of the car. It then hit Car B (SGX 2097 Z) at its right side, and also caused my car to mount the void deck.

Car B owner (Mr Dominic Ho) was on-site as well.
