We refer to your below email.

From the scene photos taken, we can see both parties are within the right 2 lanes for turning right. You mentioned that vehicle on the right side of your taxi to evidence that your taxi was on lane 2 which is not conclusive. As vehicle travelling on right lane were driving through the gap between taxi and road kerb, this gap offers more space in view of concrete road divider on the Tanjong Katong road is far behind the pedestrian crossing path.

Your taxi and our insured lorry were lying at the centre of right turning area, blocking vehicles from turning right from lane 1 & lane 2, therefore vehicles choose to drive through the gap for turning right. If you look at the photos carefully, your taxi's position is close to right edge of yellow box which is within lane 1, our insured lorry seem clearly in lane 2. 
