



#### Brief Details.

On 22.01.2019 at 1345hrs, I was driving my vehicle of registration no. SLJ2784M (Honda Vezel) at the carpark of 551 Balestier Road (open carpark) to pick-up a passenger. I stopped my vehicle adjacent to a store "no.551 SIM SIANG CHOON". After which, I alighted from my vehicle (stationary position) and assisted the female passenger with her goods to be placed at the rear booth of my vehicle. In the midst of arranging the goods, a grey van of registration no. GBH5213D (from a perpendicular position) reversed and collided onto the rear left passenger side (near the wheel area).
