*Dear Inthiran*

*Good afternoon,*

*As spoken over the phone we had provided our evidence.*

*Very clearly my vehicle is fully in lane and moving straight, the taxi on the other hand was cutting across 2 lanes.*

*Please ask the other party to submit their video evidence that they were in lane. The correct procedure for the taxi exiting that part of the roundabout is to have kept to the leftmost lane after the Keng Lee and Bukit Timah exit instead of keeping to the 2nd lane then attempting to perform a sharp left cutting across 2 lanes to exit Clemenceau Ave North causing an accident when my car was in lane and properly going straight.*

*Please show evidence that the taxi had kept to the correct lane and also the speed at which the taxi was going.*

*According to BOLA rules they are 100% liable.*

*If this persists I will look for my RTA lawyer and it would likely result in a substantial increase in insurance costs. Which is what BOLA is trying to avoid.*

Based on the Insured's video footage, the Insured driver was travelling on the middle lane of a 3 lane road and should not exit the roundabout from the middle lane; he should not move from the centre lane into the other lane only on reaching the exit, but should have changed lane some distance before the exit.

Meanwhile, TP vehicle had already entered in the roundabout and was travelling along the leftmost lane.

As such, we are of the view that liability is not to our Insured's favour.
