TP ComfortDelgro is appealing for this case. We quote their argument below:

"Your insured driver was the culprit of accident and BOLA S27 should not be applied in this matter or otherwise, it's against the public policy as it encourages drivers to seek revenge by doing such emergency brake, since the vehicle bang from behind always 100% at fault.

Please review your position and settle our claim at 100%. You may refer to a similar High Court case, **Tong Khing Kia & Anor v Yeo Kong Boon [1991] 2 MLJ 101:** High Court found the front car driver 100% liable for creating a dangerous situation which was the cause of the accident. Chao Hick Tin J (as he then was) added that "it does not follow that in the case of a front-to-rear collision, the vehicle that followed behind must necessarily be negligent to some extent.FYI, taxi's insurer had rejected your insured's claim, with the supporting of video footage evidence"
